Guidelines for selection Procedure of Aranya Bandhus.

Following guidelines may be followed in connection with selection of Aranya Bandhus in different district of West Bengal on the strength of the Memorandum No.1626-FR/O/11M-05/2014, dated 22.07.2015 :-

1. Applications will be invited by the Ex-officio Managers, West Bengal Wasteland Development Corporation Ltd. and Divisional Forest Officers having territorial jurisdictions in different districts of West Bengal on behalf of Managing Director, WBWDC Ltd. through advertisement in local newspaper.
2. Copies of the advertisement should be circulated to all Govt. offices and Panchayat Offices of the concerned Division.
3. Applications should be submitted to the respective Ex-officio Managers within 21 (twenty one) days from the date of publication of the advertisement in the local news paper.
4. A list of applications thus received and found eligible should be prepared by the concerned Ex-officio Manager, WBWDC Ltd. and forwarded to the Sabhapati of the concerned Panchayet Samity.
5. Sabhapati, Panchayat Samity should select provisionally the Aranya Bandhus from the list, Gram Panchayet-wise, within 10(ten) days from the date of receipt of the list. Concerned Range Officer and Beat Officer should be consulted by the Sabhapati in Selection of the candidates.
6. The provisionally selected list of Aranya Bandhus by the concerned Panchayat Samity in the ratio of 1:5 per Aranya Bandhu to be appointed (i.e. for each Aranya Bandhu proposed to be appointed, the Panchayet Samity should, preferably, provide a list of 5 names) and should be forwarded to the Ex-officio Manager, WBWDC Ltd., who will approve the list.
7. The concerned Chief Conservator of Forests / Conservator of Forests will form a Selection Committee comprising of the following members :-

(a) Chief Conservator of Forests / Conservator of Forests/ Field Directors/ GMs of WBFDC Ltd.	...	Chairman.
(b) Divisional Forest Officer / Deputy Field Director	...	Member Secretary.
(c) Addl/ Asstt. Divisional Forest Officer	...	Member.
(d) Range Officer (of concerned Range)	...	Member.
8. The list, as forwarded by the Panchayet Samity (in the ratio of 1:5 per Aranya Bandhu to be appointed) should be placed before the Selection Committee. Member Secretary of the Selection Committee will fix up a date for interview of the provisionally selected Aranya Bandhus, in consultation with the Chairman and invite the candidates for interview.
9. The Committee will finally select the Aranya Bandhus Gram Panchayat-wise and forward the list to the Ex-officio Manager, WBWDC Ltd.
10. Ex-officio Manager, WBWDC Ltd. will submit the lists to the Managing Director, WBWDC Ltd. for record.
11. Selected Candidates will be intimated by the concerned Ex-officio Manager, WBWDC Ltd. and obtain their acceptance of the offer of selection along with two passport size photographs and copies of address proof, to enable him to issue the Identity Cards to the selected Aranya Bandhus.
12. Copies of lists of all selected candidates should be sent to concerned Panchayat Samity and Gram Panchayat offices.
13. Training of the Selected Aranya Bandhus will be arranged in due course by Ex-officio Managers on behalf of WBWDC Ltd.
